# GoShip privacy policy

This Privacy Policy describes how your personal information is collected, used, and shared when you visit or make a purchase from goship.com (the "Site") owned and operated by GoShip ("GoShip," "we," "our," "us"). By visiting this website, you agree to be bound by the terms and conditions of this Privacy Policy. If you disagree, please do not use or access our site.

Your privacy is essential to all of us at <u>GoShip</u>. We have established this privacy policy to explain how we protect, collect, and use your personal information. It also describes your choices regarding using, accessing and correcting your personal information. Personal information is information about you that is personally identifiable such as your name, address, phone number, and e-mail address, that is not otherwise publicly available.

### Information we collect for the GoShip privacy policy

When you visit the site, we automatically collect certain information about your device, including your web browser, IP address, time zone, and some of the cookies installed on your device. Additionally, as you browse the site, we collect information about the individual web pages or products you view, what websites or search terms refer you to, and how you interact with the site. We refer to this automatically-collected information as "Device Information."

We collect Device Information using the following technologies:

- "Cookies" are data files placed on your device or computer and often include a unique anonymous identifier. For more information about cookies and how to disable cookies, visit <u>http://www.allaboutcookies.org</u>.
- "Log files" track actions occurring on the site, and collect data, including your IP address, browser type, Internet service provider, referring/exit pages, and date/time stamps.
- "Web beacons," "tags," and "pixels" are electronic files used to record information about how you browse the site.

GoShip collects information about your activity and behavior if you choose to list, quote, or match on the site. If you send us personal correspondence, such as emails or letters, or other users or third parties send us correspondence about your activities or postings on the site, we may collect such information in a file specific to you.

Additionally, when you make a purchase or attempt to purchase through the site, we collect certain information from you, including your name, billing address, shipping address, payment information (including credit card numbers, e-mail address, and phone number. We refer to this information as "Order Information."

When we talk about "Personal Information" in this Privacy Policy, we are talking both about Device Information and Order Information.

How do we use your personal information?

We use the order information we generally collect to fulfill any orders placed through the site (including processing your payment information, arranging to ship, and providing you with invoices and order confirmations). Additionally, we use this Order Information to:

- Communicate with you;
- Screen our orders for potential risk or fraud;
- When in line with the preferences you have shared with us, provide you with information or advertising relating to our products or <u>services</u>;
- Marketing efforts.

#### Additional concerns

• We use the Device Information that we collect to help us screen for potential risk and fraud (your IP address) and, more generally, to improve and optimize our site (for example, by generating analytics about how our customers browse and interact with the site, and to assess the success of our marketing and advertising campaigns); • We may use third-party advertising companies and media partners to serve ads on our website or the sites we advertise. Please note that these companies may use Usage Information about your visit to the applicable site following the policies to provide advertisements about goods and services that may interest you. In serving advertisements, these companies may place or recognize a unique cookie on your browser.

In addition, we may use web beacons provided by third-party advertising companies to help manage our online advertising. These web beacons enable us to recognize a browser's cookie when a browser visits this website to learn which advertisements bring users to our website. • We use the Device Information for remarketing purposes utilizing Google display advertisements. By using Device Information, Google remarketing will show our ads on other websites you visit. You may opt out of Google's use of Device Information by

#### Sharing your personal information

Finally, we may also share your Personal Information to comply with applicable laws and regulations, to respond to a subpoena, search warrant, or other lawful requests for information we receive, or to protect our rights otherwise.

#### Do not track

#### Data retention

When you place an order through the site, we will maintain your Order Information for our records unless and until you ask us to delete this information.

### Special note to international users

The site is hosted in the United States. If you are attempting to access the website from a physical location within the European Union, Asia, or any other region with laws or regulations governing personal data collection, use, and disclosure that differ from United States laws, please be advised that your use of the website is governed by U.S. law, this Privacy Policy, and the Terms of Use. To the extent you provide Personal Information through the website, you are transferring your Personal Information to the United States, and you consent to:

- such transfer;
- the application of the laws of the United States or the State of Pennsylvania concerning any dispute arising from or related to the Privacy Policy and your use of the site, other than such rules, regulations, case law, and international treaties that would result in the application of the laws of a jurisdiction other than the United States or the State of Pennsylvania, and;

• the exclusive jurisdiction of Butler County, Pennsylvania courts, and the federal courts in Pittsburgh, Pennsylvania.

Claims and changes in the GoShip privacy policy

Any claim or dispute between you and us arising from your use of the site or in connection with the Privacy Policy shall be decided exclusively by a competent court of competent jurisdiction in Allegheny County, Pennsylvania, U.S.A.

If you are a European resident, you have the right to access the personal information we hold about you and to ask that your personal information be corrected, updated, or deleted. If you want to exercise this right, please get in touch with us through the contact information below.

Additionally, suppose you are a European resident. In that case, we are processing your information to fulfill contracts we might have with you (for example, if you make an order through the site) or pursuing our legitimate business interests listed above.
